



WHEREAS the Author herein above mentioned have registered a Deed of Trust on 18th day of September 2001 as Document No.367 of 2001 in Book IV of Singanallur S.R.O.

WHEREAS in the meeting of the Board of Trustees it has been decided to modify certain clauses to suit the statutory requirement.

Now this deed of modification witnesses the following:

1. In Page No.3 under the heading "Constitution" Clause(2) will be deleted and the following clause will be added.

The object of the Trust is to improve the Education, Health and Social Economic conditions of the poor orphan and the needy people, irrespective of caste, creed and religion.

2. In page No.5 under the head E-GENERAL clauses 3 will be altered as follows:

E- GENERAL

3. The trust shall be administered by a Board of Trustees consisting of three Trustees, who are appointed by the Founder Trustee - Author.

(i) DR.P.P.JOB (President) S/o.Late.P.V.Porinchu residing at Kombathottam, Ravathur(Po), Irigur (Via), Coimbatore District.

(ii) MRS. DR. MARY JOB (Treasurer) M.B.B.S., W/o. Dr.P.P.Job residing at Kombathottam, Ravathur (Po), Irigur (Via), Coimbatore District.

(iii) Dr. LALI THOMAS (Secretary), D/o. O.Thomas residing at Kombathottam, Ravathur (Po), Irigur (Via), Coimbatore Dist.(Dr.Lali Thomas is appointed as trustee in the vacancy arisen by resignation of Mr.CHARLY P. VARU.).

3. In page No.7 the Clause 8(F) shall be deleted and the following clause shall be inserted.

8(f) The Trustees shall be entitled to accept deposits and of obtain loan and to invest the Trust monies either with Banks or in other Institutions. Provided always that the Trustees while investing funds of the Trust, shall not violate provisions of the Income-Tax Act 1961 under sections 11 and 13 of the said Act as is framed now or alterations to the Act that may be made in future.

4. In page No.9 the Clauses 18 and 19 will be deleted and the following clauses shall be inserted.

18. For any reasons the Trustee feel that they cannot carry on the objects of the Trust themselves with its Obligation and Liabilities, the Assets of the Trust shall be handed over or transferred to any other approved Trust or Charitable Institutions having similar objects.

19. The activities of the Trust will not be carried outside India.

20. The activities of the Trust will not be carried with the objective of profit making.

The above modifications shall form part of the original Deed of Trust.

No immovable property is affected by this Deed.
