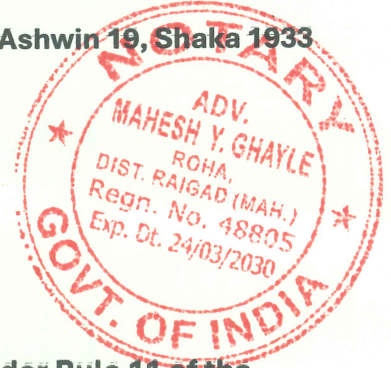

**Subject: - Regarding the issuance of recognition certificates to schools under Rule 11 of the Rights of Children to Free and Compulsory Education Act, 2009 and Rule (4) of the Free and Compulsory Education Rules, 2011 for the purpose of Section 18.**

Dear Sir/Madam,

Regarding the application made on 28/03/2025 and subsequent correspondence with the school based on the inspection conducted, I, as the Education Officer (Primary), Raigad Zilla Parishad, Alibag, hereby grant provisional recognition to **J.M. Rathi English School and Junior College, Tal. Roha, Dist. Raigad** (school name with address) for a period of three years **from 18/03/2025 to 17/03/2028** for classes 1 to 8. The above recognition is subject to the following conditions:

- 1) The duration of the recognition will not be extended, and there will be no obligation to grant recognition or affiliation after class eight under any circumstances.
- 2) The school will comply with the provisions of the Right of Children to Free and Compulsory Education Act 2009 (Annexure One) and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Annexure Two).
- 3) The school will provide admission to at least 25% of the students in the first grade from the nearby disadvantaged and marginalized groups of children and will provide free and compulsory education until primary education is completed, but it will also ensure compliance with this standard in cases of pre-primary grades.
- 4) For the children specified in paragraph 3, the school will be provided with a separate bank account to receive reimbursement under section 12(2) of the Act.
- 5) No institution/school shall collect any capitation fee. And no child shall be forced to undergo any screening process by their mother, father, or guardian.
- 6) No child shall be denied admission to school on the grounds of proof of age, religion, caste or race, place of birth, or for any such reason.
- 7) (One) Any child admitted to school shall not be held back in the same grade they are in. Nor shall they be expelled from school until they complete primary education.  
(Two) No child shall be subjected to physical punishment or mental harassment.  
(Three) No child shall be required to pass any board examination until they complete primary education.  
(Four) Each child who has completed (four) primary education shall be issued a certificate as specified under Rule 23.  
(Five) Students with disabilities / special needs will be included as per the provisions of the Act.  
(Six) Teachers who possess the minimum qualifications stipulated under Section 23 (1) of the Act shall be appointed. However, it is further stated that teachers who do not possess such minimum qualifications as of the date of commencement of the Act will have to acquire such minimum qualifications within a period of 5 years.  
(Seven) The duties specified in Section 24 (1) of the Act shall be performed by him/her/them.  
(Eight) The school shall ensure that the teacher does not engage in private tutoring.



- 8) The school will follow the curriculum prepared based on the syllabus determined by the appropriate authority.
- 9) As stipulated in Section 19 of the School Act, the school will provide admission to students in relation to the facilities available in the school.
- 10) The school shall comply with the standards and benchmarks specified in section 19 of the School Act. The facilities available at the school during the last inspection are as follows:

- Area of the school premises - 36666.44 sq. m.
- Total built-up area - 35814.44 sq. m.
- Area of the playground - 30852 sq. m.
- Number of classrooms - 40
- There is office, storage, and principal's room - Yes
- Separate restrooms for boys and girls are kept clean and hygienic for use. There will be sufficient water - Yes
- Drinking water facility - Yes
- The kitchen is available for preparing lunch - No
- There is teaching material/sports and game-related materials/library available.
- Reading material is available free of charge.

11) Unrecognized classes or groups cannot be run in the name of the school within or outside the school premises.

12) The school building or other constructions or playgrounds will be used only for the purposes of education and skill development.

13) The school is being run through institutions registered under the School Society Registration Act, 1960 (21 of 1860) or the Mumbai Public Trusts Act, 1950.

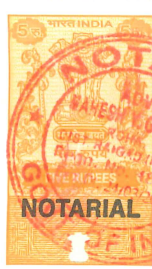
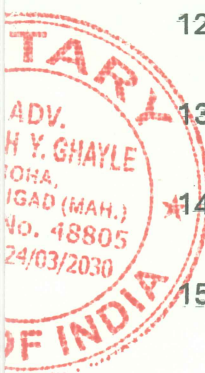
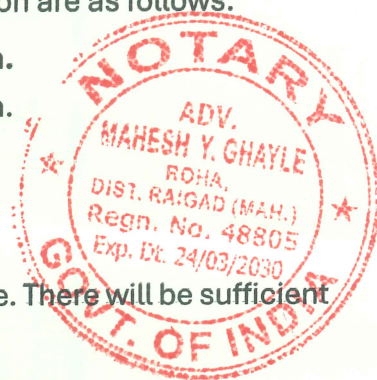
14) The school is not operated for the benefit of any group of individuals or any organization or for the purpose of making any profit.

15) The school accounts should be audited and certified by a chartered accountant, and appropriate accounting statements should be prepared as per the rules. One copy of each accounting statement should be sent to the district education authority every year.

16) The registration code granted to your school is RTE-27242108703, please mention it when corresponding with this office, take note of this.

17) The education director / district education officer should be presented with reports and information as needed, or the school should comply with any guidelines issued by the government or local authority for continuous adherence to the conditions of school approval or to rectify any deficiencies in the school's operations.

18) If there is any registration of the institution, ensure that it is renewed.

आपण केलेल्या दिनांक २८/०३/२०२५ रोजीच्या अर्जाच्या संदर्भात आणि त्यानंतर यासंदर्भात शाळेशी केलेला पत्रव्यवहार/ शाळेची केलेली तपासणी या आधारे मी शिक्षणाधिकारी (प्राथमिक) रायगड जिल्हा परिषद, अलिबाग दिनांक १८/०३/२०२५ पासून दिनांक १७/०३/२०२८ या तीन वर्षांच्या कालावधीसाठी इयत्ता १ली ते इयत्ता ८वी वर्गाचे जे.एम.राठी इंग्लिश स्कूल अँड ज्युनियर कॉलेज

ता.रोहा जि.रायगड या (शाळेचे नांव पत्त्यासह) शाळेस तात्पुरती मान्यता देत आहे.

वरील मान्यता ही खालील शर्तीच्या पूर्ततेच्या अधीन आहे :-

- 1) मान्यतेचा कालावधी वाढवून मिळणार नाही. आणि इयत्ता आठवीनंतर मान्यता किंवा संलग्नता देण्यास कोणत्याही परिस्थितीत कोणतेही बंधन नसेल.

- 4) परिच्छेद 3 मध्ये निर्दिष्ट केलेल्या बालकांकरिता शाळेला अधिनियमाच्या कलम 12(2) नुसार प्रतिपूर्ती मिळेल अशी प्रतिपूर्ती मिळण्यासाठी शाळेला स्वतंत्र बँक खाते देण्यात येईल.
- 5) संस्था/शाळा कोणतीही कंपिटेशन फी वसूल करणार नाही. आणि कोणत्याही छाननी पध्दतीसाठी बालकांस किंवा त्याच्या किंवा तिच्या मात्या-पित्यास किंवा पालकास भाग पाडणार नाही.
- 6) कोणत्याही बालकास वयाच्या पुराव्याच्या अभावी, धर्म, जात किंवा वंश, जन्मठिकाण किंवा यापैकी कोणत्याही कारणास्तव, शाळेमध्ये प्रवेश नाकारण्यात येणार नाही.
- 7) (एक) शाळेत प्रवेश दिलेल्या कोणत्याही बालकास तो ज्या इयत्तेत असेल त्याच इयत्तेत रोखून ठेवले जाणार नाही. किंवा प्राथमिक शिक्षण पूर्ण होईपर्यंत शाळेतून काढून टाकण्यात येणार नाही.  
(दोन) कोणत्याही बालकास शारीरिक शिक्षा किंवा मानसिक त्रास देण्यात येणार नाही.

- 8) शाळा समुचित प्राधिकरणाने निर्धारित केलेल्या अभ्यासक्रमाच्या आधारे तयार केलेल्या पाठ्यक्रमाचे पालन करील.
- 9) शाळा अधिनियमाच्या कलम 19 मध्ये विहित केल्या प्रमाणे शाळेत उपलब्ध असलेल्या सुविधांच्या तुलनेत विद्यार्थ्यांना प्रवेश देईल.
- 10) शाळा अधिनियमाच्या कलम 19 मध्ये निर्दिष्ट केलेल्या मानकांचे व प्रमाणकांचे पालन करील.

Jagannath Rathi Charity Trust, Pune" and to state that the State Government has No Objection for C.B.S.E. affiliation to the school for **Std.I to Std.XII** subject to fulfillment of different conditions laid down in the Government Resolution, School Education and Sports Department, No. NOC. 2009/(663/09)/SE-1, dated 20/6/2012 as well as following conditions:-

1. Like all other schools in the State, Section 18 & 19 of the Right of Children to Free and Compulsory Education Act, 2009 and its Schedule as well as Rules, Orders, Notifications and Circulars etc. issued by the State Government from time to time under this Act shall be applicable to the said school.
2. Institution shall abide by the provision of Section 12(1)(C) of RTE Act, 2009 and Maharashtra RTE Rules 2011.
3. RTE Act, 2009 provides for Inclusive Education thus children with special needs (CWSN) called " Divyang " shall be part of every class in the school. However, " Divyang" children need special policy pronouncements. The State of Maharashtra is framing and issuing various policies in this respect. Government recently issued Resolution No. Mise 2015 / (119-A)/ SD-6 Dated 8<sup>th</sup> January,2016 in this regard, this Government Resolution is abiding. All directives, decisions and policies shall be abided by all schools of all boards including international boards.
4. State's all Educational Acts, Rules, Orders and Policies made time to time shall be applicable to the said school.
5. Curriculum of the State Board or respective Board shall be compulsory for I to VIII Standard.
6. Marathi language subject shall be taught from I to VIII standard.
7. Staff salaries shall not be paid lesser than the Schedule 'C' of Maharashtra Employees of Private Schools (Conditions of Service) Regulation Act, 1981.

8. The management shall follow the traffic and safety guidelines indicated by the Police, Fire Services and Transport Department from time to time. The instructions issued by Circular No. 21748/DI/97 dated 16/2/1998 and No. PRE-2008/506/11/Prashi-1 dated 14/7/2011 & other orders of transport department for safe transportation of school children should be scrupulously followed. The management shall provide fire protection arrangement as prescribed in the National Building Code of India, Part-IV Fire 1997 and there are amendments made from time to time.
  9. The school shall conduct 3 tests annually for all children upto Standard VIII and provide information about children achievements in SARAL database as per the provisions of Pragat shaikshanik Maharashtra Government Resolution dated 22<sup>nd</sup> june 2015.
  10. Childwise information as sought in SARAL and every other information as sought in U-DISE shall be provided by the school from time to time as demanded by the State Authorities.
  11. Institution shall abide by the policy and Maharashtra Educational Institutions (Regulation of Fees) Act, 2011 made by the State Government regarding Regulation of fees.
  12. Indian History especially "History related to Maharashtra" shall be taught in the school. Failing which this No Objection Certificate shall be withdrawn.
  13. The Complaint Redressal Committee regarding sexual harassment at school premises should be formed as per government resolution, woman and child department No. मकचौ-२०१३/ प्र.क्र.६३ /मकक, Dated 19.6.2014 and subsequent provisions in Act and Rules
  14. The State Government reserves the rights to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
